## General objectives for quality:

- Provide products that meet regulatory requirements.

## General objectives for the environment:

- Take care of the surrounding environment and maintain good relations with the populations residing near the operational site:
- Make every effort to protect the environment;
- Pursue a policy of continuous improvement of its environmental performance, minimizing, where technically speaking
  possible and economically sustainable, any negative impact on the environment of its activities;
- Carefully monitor all processes (internal and / or otherwise connected to them) on environmental impacts;

- Inform suppliers of goods and services about the contents of the Environmental Policy;
- Eliminate or reduce emissions, discharges and waste, adopt the technological processes that offer the best environmental impacts in technical and economic terms;

- Evaluate the environmental aspects of operating activities and adopt management procedures that ensure that plants and processes offer greater protection of the environment;
- Carry out training activities for all employees to encourage any initiative aimed at protecting the environment;
